Partnership: Key to Economic Development

Partnerships drive the mission of the Champaign Economic Partnership (CEP)—to grow business and jobs and improve quality of life in Champaign County, Ohio.

The CEP's motto, Working Together for Success, says it all.

Established July 1, 2015, the CEP serves as Champaign County's designated economic development agency, through an agreement with the Champaign County commissioners and the City of Urbana.

The CEP operates as a private-public partnership of private businesses, the Champaign County Community Improvement Corporation (CIC) and local government subdivisions—county, city, villages and townships.

Private business representatives hold about 70 percent of the 18 seats on the CEP board of trustees. The rest are held by local government representatives.

Before becoming economic development director of the Champaign Economic Partnership, Marcia Bailey served as economic development coordinator for the City of Urbana.

In her role with the city, Bailey also assisted Champaign County with economic development. But now she directs a coordinated, countywide effort to strengthen the local economy.

CEP Sponsors

The Champaign Economic Partnership is funded by public and private sponsors.

Public funding for the agency's work to attract and retain business comes from the Champaign County commissioners and the City of Urbana, which each contribute \$50,000.

Private funding comes from Pioneer Electric Cooperative and Dayton Power & Light, which have each contributed \$15,000. Security National Bank, Civista Bank, CT Communications and ComDoc provide the CEP

CEP Working on 25 Projects

The Champaign Economic Partnership is working on about 25 economic development projects. These include possible expansions of existing businesses and inquiries for new businesses in service, retail, manufacturing and health care.

The projects represent more than 300 potential new jobs. One project would involve an investment of more than \$57 million by the business, said Marcia Bailey, CEP director.

In all cases, the CEP keeps projects confidential until plans are finalized.

Potential economic development projects come to the CEP through a variety of channels such as:

- Businesses wanting to expand or locate in Champaign County
- Entrepreneurs wanting to start up a business
- Site selectors that represent businesses looking for available property
- Referrals from other businesses

To move projects forward, the CEP connects businesses with local and state resources to help them find property, work out zoning and permitting, address transportation or infrastructure issues, help with work-

All Companies Complying with Tax Abatement Agreements

In some cases, new and expanding businesses are granted temporary property tax abatements in return for their commitment to invest in facilities and equipment and to retain or create a specific number of jobs.

All Champaign County companies currently operating under enterprise zone agreements and community reinvestment area agreements, which provide tax abatements, have followed through on their commitments.

Because of this, Champaign County's Tax Incentive Review Committee (TIRC) recommended to Urbana City Council and Champaign County commissioners to continue the business' tax incentives. TIRC reviews the agreements annually.

"These agreements are a very effective tool to help companies expand or locate in Champaign County," Marcia Bailey, CEP director, said. "The tax abatements are only temporary, and in the long run the investments made by the businesses increase local property taxes and strengthen local employment."

The continued tax abatement agreements represent:

- A total of \$7,269,900 in real property investment
- A total of \$24,808,813 in personal property investment for new equipment
- Retention of 279 jobs
- Creation of 53 new jobs

Agreements were continued for KTH Parts Industries, Inc., American Pan Company, Ultra-Met Company, Gerald Shiffer (for a hangar at Grimes Field) and White's Service Center.

In addition, an enterprise zone agreement with Parker Trutec came to the successful completion of its term, resulting in 88 retained jobs and two new jobs and investments of \$1,617,453 in real property and \$506,406 in personal property.

Focusing on Workforce Development

Employees are a business' most valuable asset. And because manufacturers in Champaign County—and across the U.S.—face a shortage of job applicants with the training necessary for skilled, high-tech positions, the CEP has made work-force development one of its primary focuses.

CEP Director Marcia Bailey explains, "Preparing our local workforce for skilled, technical jobs is a key to strengthening and growing our local economy. To grow their businesses, existing companies need well-trained employees. And companies building a new facility locate where the workforce is plentiful and well-trained."

The CEP is partnering with educational institutions, the Champaign County Manufacturers Council and the council's Human Resources Managers Group to prepare the workforce. The HR Group is reaching out to schools and students, to promote products made by local manufacturers, while educating students about the rewarding, high-tech career opportunities local manufacturers offer and the training needed to prepare for them.

Progress is being made. For instance, Ohio Hi-Point Career Center is completing the first year of an advanced manufacturing satellite program for fifth grade through high school at Triad Local Schools.

The CEP also is collaborating on workforce development with the economic development agencies of Union and Madison counties, as well as regional employers and educational institutions.

Unemployment Down, Manufacturing Jobs on the Rise

Unemployment rates have substantially decreased in Champaign County since 2012, according to statistics from the Bureau of Labor Market Information—from an average of 7.4 percent in 2012 to an average of 4.3 percent in 2015.

And in the past three years, Champaign County has added 900 manufacturing jobs, reports Marcia Bailey, economic devel-
