The cooperative, which celebrated its 85th anniversary in 2020, serves nearly 17,000 consumermembers, 5,569 in Champaign County. Pioneer supported economic development in its three primary counties with a total contribution of \$10,500. reliability include a five-year meter exchange project. In 2020, Pioneer returned more than \$3.5 million in capital credits to current and former co-op members.

#### **Darby & Urbana Dental Smiles**

Urbana Dental Smiles is preparing to break ground for a 1,000-square-foot addition to better serve patients and allow the practice to add orthodontics – a new

service for the county. The



practice's dentists, Dr. Jessica Kile and Dr. Marta Lovell, will complete two-year orthodontic residency training in December.



Dr. Lovell is becoming a partner after six years with the practice, and Dr. Kile won the Ohio Dental Association's Young Dentist of the Year Award in

Drs. Kile & Lovell 2020.

Also, the Urbana office is adding a Cone beam CT that produces 3D images, and Darby Dental is completing a new façade that will add to the aesthetics of downtown Mechanicsburg.

## **CEP Helps Plan Job Fair**

The CEP recently offered guidance to Rittal, an Advocate Level CEP partnership investor, in planning and marketing a job fair at the county



fairgrounds. The event resulted in 12 new hires, filling about a fourth of Rittal's then open assembly, machine operator and paint line positions.

CEP Director Marcia Bailey connected Katie McKee, Rittal human resources specialist, with CEP partners Staci Wisma of ChampaignWorks.com and Andrea Mitchell of OhioMeansJobs Champaign County. They attended planning meetings and assisted with job fair promotion.

"I appreciate the insight and support they provided to help us coordinate a successful event, and I thank our supervisors and managers who screened and interviewed job fair attendees," McKee said.

#### Increases in Benefits and Bonuses

The new hires will receive a sign-on bonus after their first 90 days without an absence. McKee adds that Rittal recently raised wages, benefits and bonuses to promote employee recruitment and retention. Rittal pays a \$1,000 retention bonus each work anniversary; a \$600 bonus for employees who refer a new employee (increased from \$500); a \$300 bonus for referred employees; and a monthly perfect attendance bonus (increased from quarterly).

Rittal continues to recruit new employees.

"Construction for the full project is approximately 50 percent complete," reports Duane Miller, president of F&C Legacy Place. "The two schools (Legacy Place North and Legacy Place South) are planning to open by the end of the second quarter of 2021, and the Douglas (Legacy Place Monument Square) plans to come on line in December of 2021.'



The Urbana South Elementary gym will be Legacy Place South's community room, including a stage.

He added, "Projects like these take a lot of community-minded people who not only love to help people live in quality affordable housing, but also love to see downtowns restored to life. We look forward to seeing how this development will spur on other community and economic developments in the beautiful town of Urbana."

## **CEP Helps Distribute \$700,000** in CARES Funds to Businesses

From March through December 2020 - in three rounds of grant applications - \$696,529.55 in CARES Act funding was granted to 82 small Champaign County businesses impacted by the pandemic.

## **BR-1 Zoning Changes in Urbana Being Explored to Promote Small Business**

To make it easier for new small businesses - like retail stores and restaurants - to find locations in Urbana, the CEP and City of Urbana have begun exploring ways to modify regulations for BR-1 (businessresidential) zoned districts in the city.

Late last year, CEP Director Marcia Bailey and the CEP Board of Trustees wrote to the city to encourage consideration of rezoning BR-1 districts or revising the BR-1 permitted and/or conditional use definition to help promote small business development in the city.

A zoning committee established by Urbana City Council has started discussing this issue, City Councilman Pat Thackery, a former CEP Board member, said. He adds that City Council's economic development committee will begin working toward an economic development plan for the city.

As she's helped new small businesses find sites in Urbana to set up shop, Bailey said she has found that few suitable locations are available in B2 (general business) and B3 (central business) districts in the city. She adds, "There are available sites - land and buildings - in BR-1 districts, but the current definition for permitted

uses in these areas, don't accommodate small businesses like restaurants and retail. These properties remain undeveloped."

Currently, permitted uses in BR-1 districts include multifamily and single-family dwellings, as well as personal services, while conditionally permitted uses include offices, home occupations, bed and breakfasts and childcare. among a few others.

Bailey said that stakeholder feedback to the city's Urbana South Main Street Corridor Plan recommends that the city reevaluate BR-1 zoning to allow for small businesses that are supported by pedestrianoriented traffic and are compatible with residential uses to enhance the city's southern gateway.

In addition to addressing BR-1 zoning the city is also reviewing and updating zoningrelated ordinances that pertain to fences, nuisances and other issues. Kerry Brugger, Urbana's Director of Administration, said that Dusty Hurst, Mechanicsburg zoning inspector, is currently working on a six-month contract to assist the city in this project and support the city's new zoning officer, Preston Carter.

### New Substation to Power Growth

Until recently, all of Urbana's residential and commercial electric power needs were supplied through two substations, the Kings Creek substation, about 2.5 miles north of the center of town, and the Urbana substation, about 2 miles south.

"Urbana has grown beyond the capacity of these two existing substations," Rob Beeler, AES Ohio customer business manager, explains. So, AES Ohio, previously known as Dayton Power & Light (an Advocate Level CEP partnership investor), recently added a third substation on South Edgewood Avenue.

"The new substation allows us to



ensure adequate capacity and reliability for our customers, closer to the load center (that is, the primary concentration of electrical users, including manufacturing facilities)," Beeler said.

**CEP Director Marcia Bailey** said, "We are grateful to AES Ohio for closely monitoring growth in our community and ensuring we have electrical supply to support continuing economic growth. This furthers our efforts to make Urbana and Champaign County the place for businesses to grow and families to thrive."

Amid the pandemic challenges of 2020, the CEP helped move forward 15 economic development projects (retail, manufacturing, service and hospitality) that created 100 new jobs and resulted in about \$40 million in investment in Champaign County.

The CEP's role in these projects included the site selection process, coordinating communication between entities involved in the projects, assisting with incentive applications and efforts to retain existing jobs.

"Despite the obstacles, our county made encouraging progress, and the progress continues in 2021 with new businesses and major ongoing projects like Legacy Place Apartments and restoration of the former Q3/ Johnson Manufacturing property, where three businesses will open this fall,' **CEP Director Marcia Bailey** said.

#### KTH Parts Industries, Inc.

Champaign County's largest employer, KTH is one of the largest Tier 1 automotive suppliers in the U.S., employing more than 1,100 associates in a 1.068-million-square-foot complex west of St. Paris. KTH makes underbody structural frame components for cars. Honda is KTH's top customer.



KTH started out in 1985 in a 250,000-square-foot facility, west of St. Paris, with 250 associates, and has since expanded 37 times.

Chris Millice, KTH's Senior Vice President of General Administration, credits the CEP for helping KTH grow its footprint and workforce in Champaign County. "The CEP has always been 100 percent behind manufacturing. They're always coming out to see what we need in the way of workforce." Plus, he says, the CEP helped KTH obtain tax incentives through the Community Reinvestment Area program to help make the expansions and job growth possible.

He adds, "At KTH we pride ourselves on our dedicated workforce, which is one of the best in the industry, as we work through labor demand constraints and follow COVID safe practices."

#### **Memorial Health**

Memorial Health, which opened its 30,000-square-foot Urbana outpatient medical facility in 2018 with support from the CEP, opened two new facilities in Marysville in 2020: a 77,000-square-foot inpatient pavilion with 36 universal patient rooms and a 30,000-square-



foot outpatient pavilion.
